BES to Upgrade Nonconforming Sewers – Who Pays?

According to the Bureau of Environmental Services map we received from Matt Hickey last year, just over 100 households in Sunnyside have sewer connections that are deemed out of compliance. Many of us received letters in June asking us to return a signed and notarized form committing to pay between \$6,100 and \$18,300 in anticipation of BES installing a proper sewer in the street (according to Matt, this work is expected to be performed in 2013-2014).

Communication from BES on this issue has been rather terse, and some

of us feel that we'd like to understand better what our options are, whether all of this proposed work is necessary, and if there might be other solutions besides the one outlined by BES. I've communicated with Commissioner Saltzman's office, with BES, and with other neighborhood leaders across the city about this issue. We've also discussed this on our neighborhood listserv.

Our nonconforming sewer connections fall into at least two categories:

- 1) Party lines where the connection from the drain pipe does not go straight to the public right of way but crosses a neighbor's property first.
- 2) Private sewer lines that were installed in the public right of way.

In the second letter I received from BES in June, mention was made of the rules governing this issue: Portland city code 17.33, which can be found at www.portlandonline.com/auditor/index.cfm?c=28860. A number of questions remain unanswered, however. What are estimated total costs to homeowners of these "upgrades"? These include the cost of permits, the cost to connect up to the city sewer, as well as the Public Sewer Utility Waiver mentioned above. How much of this work can or must be performed by a contractor or the homeowner? And finally, what is the logic by which homeowners are being compelled to pay for these upgrades to sewer lines, some of which are already in the public right of way?

One problem seems to be that the nonconforming sewers come in many flavors, and BES is treating them all more or less the same. We are hoping

to convince them to take a closer look at the particulars, especially where we feel that the sewers deemed noncompliant are (or may be—they haven't checked) physically identical to compliant sewers on other blocks.

Feel free to join the conversation on our listserv, or to attend the event organized by the Brooklyn Action Corps, which is asking as many people as possible to attend their general meeting at 7 p.m. on July 27 at the Loaves and Fishes Center (SE Milwaukie and Center Street) to discuss the nonconforming sewer issue. Commissioner Saltzman has also been invited to speak.

Get Involved in Research about SE Portland Neighborhood Nature

What are the benefits of small-scale natural areas in our neighborhoods? Your participation in a study about watershed health and neighborhood nature will help researchers find out more about the benefits of small-scale neighborhood-oriented nature.

Help Us Build the Southeast Uplift Commons!

Southeast Uplift, the nonprofit neighborhood coalition representing 20 neighborhood associations in southeast Portland, is continuing work to convert our grounds at 3534 SE Main into a valued community space. Last year, with a grant from East Multnomah Soil and Water Conservation District, we pulled up 300 square feet of asphalt in our parking lot and replaced it with a bioswale. We also built two rain gardens to collect stormwater from our roof. The projects are treating runoff from nearly 4,000 square feet of impervious surface!

With a second grant from EMSWCD

we will replace 3,000 square feet of grass and invasive weeds with native plants. We are partnering with the Herb Shoppe on Hawthorne to include medicinal plants and habitat for native pollinators. Our vision for the space includes native plants with signage to show visitors what they're seeing, a meandering trail through the site, and a sitting area for our tenants and visitors. We hope to host workshops on

medicinal plants and to provide garden space for the community to share in the future.

This project will rely on support from volunteers to help with the work, and input from the community to make the space something people in the neighborhood can enjoy. The first work party will be held on Saturday, July 9. We will be pulling up invasive plants, covering up grass, and marking future trails. 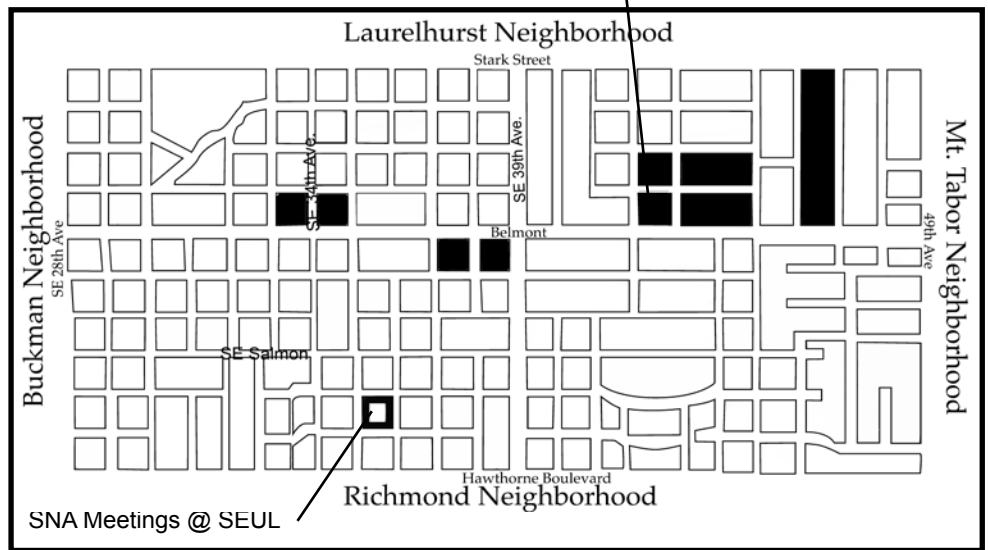
