### **PPB Report – Officer Stuart Fox**

Last month 3 vehicle thefts, some residential burglary and commercial burglary. Car prowls are starting to increase on lower Burnside and Morrison. Officer reminded neighbors to leave if you come home if you suspect something is wrong. He also reminded neighbors who are bikers to have lights that are visible 500 feet or more, and reflective gear.

### **Debbie Castleton-Bureau of Environmental Services-Community Outreach**

Debbie reported she is no longer the outreach coordinator for the Sunnyside North Sewer project-Ning has taken this role. The Hawthorne pipework has been pulled from the project because the paving project takes priority. They are working on project planning and design. Pipes will be repaired and replaced where needed.

### **Hawthorne Repainting/repaving planning overview-Karla Kingsley, Bureau of Transportation**

PBOT repaving Hawthorne 24<sup>th</sup> Avenue to 50<sup>th</sup> scheduled for Summer 2021.BES sewer pipe work scheduled prior to this.

Karla outlined the project: Funded: Repaving and Re-striping. New curb ramps where they don't meet ADA standards.

Potential: new crossings, some with islands, transit efficiency enhancements, other low-cost changes.

Beyond Summer 2021: changes to 12 ave through 24<sup>th</sup> Ave, Further investments for the extent of the corridor, additional transit enhancements

Key Goals: take advantage of near-term opportunity: fit within the scope of re-paving, Document additional needs for future investment
